

Privacy Policy

This Privacy Policy (hereinafter referred to as this "Policy") describes how NEON GAS LABS CORP (hereinafter referred to as this "Company") handles the personal information of users (hereinafter referred to as "Users") of the website (hereinafter referred to as this "Service") provided by this Company. This rule constitutes as part of the Terms of Use and is applied when the User uses this Service and when we use and manage the personal information obtained from the User.

This Policy does not apply to personal information obtained from Users via advertisements posted about this Service, or via persons providing information or services through this Service unless otherwise specified in this Policy. This does not apply to persons other than the User of this Service.

Article1 Definition and Protection of Personal Information

- (1) The term "Personal Information" as used herein shall refer to information such as name, date of birth, e-mail address, etc. of a User (but only an individual), which can identify a specific individual by its description (including information that can be easily cross-checked with other information, thereby identifying a specific individual).
- (2) We are the sole owner of the User's personal information obtained by the Company on the Service (hereinafter referred to as "Personal Information") and will manage this Personal Information in accordance with these rules.

Article2 Purpose of the Usage of Personal Information

- (1) The purpose of our use of Personal Information is as follows. As a general rule, we do not use Personal Information for any other purposes. However, this shall not apply in cases whereby the "Act on the Protection of Personal Information" (hereinafter referred to as "Personal Information Protection Law") does not require prior notification to the User or public announcement of such information.
 - 1 For smooth operation of this Service
 - 2 To provide you with information regarding this Service
 - 3 To connect with other services, such as SNS
 - 4 To provide information on our advertisers
 - 5 To contact the User by responding to inquiries from the User, etc
 - 6 To prevent unauthorized use
 - 7 To respond to disputes, lawsuits, etc
 - 8 Game Guild

Article3 Third Party Offer

- (1) We will not provide your personal information to any third party without your consent. However, we may provide or disclose your personal information to third parties in the following cases and as permitted under the Personal Information Protection Law.
 - 1 When it is necessary to provide Personal Information to the party to whom the Personal Information is entrusted in accordance with Section 4 in order to achieve the usage objectives set forth in Section 2.
 - 2 When we receive a judgment, order, inquiry, or request from a court of law, police, tax office, or any other authority authorized by law or ordinance.
 - 3 When we deem it necessary to protect the life, body, rights or property of a third party or our Company, and when we deem it difficult or inappropriate to obtain the User's consent.

Article4 Deposit of Personal Information

- (1) We may outsource User support services, system improvement and maintenance, as well as information processing to other companies to which we may entrust personal information. In such cases, we will select a subcontractor that meets our standards for

protection of human information and will enter into a confidentiality agreement with such subcontractor before entrusting them with such information.

Article5 Disclaimer

- (1) In the event that a User automatically discloses personal information etc. on this service without a request from us, there is a possibility that the information will be collected and used by a third party. We will not be held responsible for any damages incurred by the User as a result of this.

Article6 Display, Correction, Deletion, etc of User's Personal Information

- (1) When we receive a request from a User to display, correct, add, delete or stop using his/her personal information, we will confirm the User's identity by a method we deem appropriate, and if we deem appropriate, we will promptly take measures to disclose, correct, add, delete or stop using the personal information to a reasonable extent. We will implement measures to disclose, correct, add, delete or stop using your personal information as soon as reasonably possible.

Article7 Revision of these Rules and Regulations

- (1) We reserve the right to revise all or part of the Terms and Conditions without the consent of the User. However, if the Company judges that the change is important, the Company will notify the User in an easy-to-understand manner on the Service.
